



- Serving Those In Need -

The Hudson Community Foundation (HCF) has made its first distributions to local non-profit organizations helping Hudsonites overcome obstacles related to the COVID-19 virus. Donations were collected from local donors who responded to the foundation's appeal for contributions specifically related to the virus and its impact on local families. *Sincere thanks to those who have contributed to HCF* to support our community especially this time of need.

The ripple of COVID-19 has demonstrated once again the value and importance of a locally-responsive community foundation such as ours. We are here to serve our donors and neighbors in need. In particular, \$5,000 was contributed by HCF to the Hudson Food Pantry, an initiative of the Hudson Community Service Association which distributes food and basic household supplies to Hudson families in need.

At its March 28 distribution, food was provided for 148 Hudsonites, including 58 children and 19 people over age 60. More than one-third of these families were first-time Hudson Food Pantry recipients and another 7% have not used the pantry for three years.

The food pantry's inventory was depleted and it is in desperate need of cash contributions, which can be made to HCF, to procure food for the next distribution, for which an unprecedented demand is expected. HCF's is collecting COVID-19 relief funds to our **Hudson NOW Fund**, which benefits various social service organizations who are serving needs in Hudson.

We recognize that the impact of COVID19 will endure in our community for some time to come, so we continue to encourage contributions that support our mission for serving Hudson's philanthropic needs. 100% of your tax-deductible gift goes to support locally focused charitable programs.
